Reddelien Rd., Oconomowoc, WI, 53066, for property owned by Robert E. Reddelien Revocable Trust, W394 N5026 Reddelien Rd, Oconomowoc, WI, 53066, to amend the District Zoning Map of the Waukesha County Zoning Code to rezone the subject property described below from the A-T Agricultural Transition District to the R-1 Residential District to allow an approximate 2.08 acre parcel to be divided from the parent parcel.
