CONSIDER AND ACT ON THE CONDITIONAL USE REQUEST (CU 132) OF MICHAEL BOREL, N50 W35046 WISCONSIN AVE, OKAUCHEE, WI 53069, FOR LAND ALTERING ACTIVITIES ASSOCAITED WITH THE CONSTRUCTION OF A NEW RESIDENCE. THE SUBJECT PROPERTY IS DESCRIBED AS LOT 40 MAPLEWOOD CONTINUATION, PART OF THE E ½ OF SECTION 35 AND PART OF THE SW ¼ OF SECTION 36, T8N, R17E, VILLAGE OF LAC LA BELLE. MORE SPECIFICALLY, THE PROPERTY IS LOCATED AT N50 W35046 WISCONSIN AVE (TAX KEY NO. OCOT 0569.141):

Village Planner Heermans did a brief recap of Michael Borel's request. The applicant is proposing an exposed basement which will require a retaining wall. The applicant went in front of the Board of Appeals, and the Board did cap the height of the retaining wall at 4 feet. The applicant will need to revise the grading plan. MORE SPECIFICALLY, THE PROPERTY IS LOCATED AT W345 N5720 ROAD G, OCONOMOWOC, WI 53066 (TAX KEY NO OCOT 531.025 AND OCOT 0531.987):

The applicant is proposing to split the lot into 3 residential parcels. The approval of the CSM is contingent upon further documentation from the DNR as far as wells and buildability of this parcel due to the documented landfill on it.
